

The City of Little Rock has amended its 2008 Consolidated Plan to include the Community Development Block Grant – Recovery Program (CDBG-R). This new initiative, through the Department of Housing and Urban Development, is part of the American Recovery and Reinvestment Act. CDBG-R will provide funds in the amount of \$446,096 to replace deteriorated infrastructure in low- and moderate-income residential neighborhoods within the City of Little Rock.

A. CDBG-R Information by Activity

(1) Activity Name:

2009 CDBG-R Infrastructure Project

(2) Activity Narrative:

This project will replace deteriorated and aging sidewalks in low- and moderate-income residential neighborhoods. A list of sidewalk locations is attached.

By selecting an infrastructure project, the City of Little Rock has ensured the creation of jobs within an employment and product sector that has been hard hit by the declining economy in that \$423,791 will flow into local economy, creating 18 jobs in that sector. In addition, construction materials will be purchased from local suppliers, providing for sustained employment in that area. The multiplier effect of this funding is that those employed will pay local, state, and federal taxes, will purchase goods and services locally, thereby impacting other employment sectors.

This project will make a long-term impact on the neighborhoods by improving the safety of pedestrians thereby encouraging residents of the neighborhood to walk to church, local shops and services, and by affording citizens better access to public transportation. The selected drainage projects will alleviate flooding problems during heavy rains which negatively impact residential properties and the health and safety of neighborhood residents. The investment in the infrastructure will also improve the overall appearance of the neighborhood, fostering neighborhood pride and improved property values.

In order to comply with the applicable requirements, the City will award contracts for at least 50% of the projects within 120 calendar days from the date the funding was made available.

The City proposes the following schedule:

Bid Preparation:	May 2009
Advertising for Bids:	May 2009
Bid Opening:	early-June 2009
Contract Award:	mid-June 2009
Construction Start	mid-September 2009
Construction:	mid-March 2010

(3) Jobs Created:

An estimated 18 construction sector jobs will be created by the use of this funding.

(4) Additional Activity Information:

By providing better pedestrian access, residents are more likely to walk to reasonably close destinations rather than driving automobiles, and will provide better pedestrian access to public transportation.
