2. Briefly describe the process(es) indicated in question 1 above (limit 250 words).

Response: The City of Little Rock seeks to use member agencies of the local Continuum of Care to implement the programs and services funded through the HPRP. This will effectively leverage an extensive knowledge base about how to meet the needs of the homeless or those at risk of becoming homeless most effectively. To identify the specific agencies to contract with, the City will issue a Request for Qualifications to select the most qualified local service provider(s) to deliver the planned services to prospective clients. The organizations submitting qualifications will be evaluated by a review committee and up to three (3) will be selected. A contract will be negotiated with highest scoring organizations.

3. Briefly describe the process the grantee plans to use, once HUD signs the grant agreement, to allocate funds available to subgrantees by September 30, 2009, as required by the HPRP Notice (limit 250 words).

Response: The City of Little Rock will issue a Request for Qualifications within 30 days of the submission of its substantial amendment to HUD. Qualifications will be accepted and reviewed and the highest scoring organizations identified. Contracts will be awarded to the highest scoring organizations within 14 days of executing signed grant agreements with HUD.

4. Describe the grantee's plan for ensuring the effective and timely use of HPRP grant funds on eligible activities, as outlined in the HPRP Notice. Include a description of how the grantee plans to oversee and monitor the administration and use of its own HPRP funds, as well as those used by its subgrantees (limit 500 words).

Response: The City of Little Rock will execute and oversee HPRP-funded contracts with subgrantees for eligible activities according to program guidelines and will ensure that all requirements are met. Goals for timely expenditures and program progress will be included in each contract along with other performance criteria, and will be evaluated by City staff on a quarterly basis. Where deemed necessary by the City, adjustments to contracts may be made to target funds to more efficiently performing subgrantees. The City will hold a pre-implementation workshop with subgrantees, make initial technical assistance visits to each subgrantee's site to discuss goals and record keeping, and provide on-site monitoring to review case files for eligibility of clients and expenditures. The City will require monthly data reports to accompany requests for reimbursement from grant funds. The City will utilize administrative funds to hire a staff person to work directly with the City's Homeless Services Coordinator to review

performance and progress of the subgrantees and perform other required administrative duties of the HPRP program.

D. Collaboration

Response:

The City of Little Rock is engaged in comprehensive community planning process in the implementation of a plan to end chronic homelessness. This planning process represents a broad cross-section of community representatives, including Education, Health and Human Services and Labor. In addition, City staff has established regular meeting schedules to review American and Reinvestment Act funds awarded in this community and discuss how collaboration with various grants may occur. Multi-agency work groups can be identified to increase this Because of the complexity of needs of the target collaborative process. populations, multiple agencies will have an interest and the identification of overlapping problems will be made through the case management services provided through use of the HPRP funding. Protocols will be developed and implemented to assist in establishing eligibility procedures for obtaining services through these agencies. Access to information regarding services from agencies will be insured through the provision of staff training. Some prospective outcomes for collaborating with these various agencies are :

- ▶ U.S. DOE GED, HS Diploma, Vocational training
- > **HHS** Mainstream services, Medicaid, food stamps
- Labor Employability skills, job training, employment
- Homeland Security Identification and other documents required to receive services and obtain employment.
- 2. Briefly describe how the grantee plans to collaborate with appropriate Continuum(s) of Care and mainstream resources regarding HPRP activities (limit 250 words).

Response:

The City of Little Rock is an active participant in the central Arkansas Continuum of Care and the State Interagency Council on Homelessness. Information regarding the availability and proposed uses of the HPRP funding will be disseminated through these monthly meeting. Other resources, to provide special service needs

are available through various organizations within the Continuum. Many of these agencies are accessing mainstream services and are familiar with documentation and eligibility requirements. This process will prevent duplication of effort and allow for leveraging of services. The City further plans to issue Requests for Qualifications to award sub grants to up to three organizations. Eligible recipients must be participants in the Continuum of Care process.

3. Briefly describe how HPRP grant funds for financial assistance and housing relocation/stabilization services will be used in a manner that is consistent with the grantee's Consolidated Plan (limit 250 words).

Response:

The Consolidated Plan provides for addressing the identified needs for housing assistance for those designated as "very low income" whose household incomes are at or below 50% of the adjusted family median income. Approximately 68% of those households are paying more than 30% of their income for housing. Of that number 69% are renters. These households are considered to be cost burdened. The HPRP grant funds will address Plan goals of improving the condition of housing for low-income renters. This includes:

- Insuring habitability standards,
- > Increasing the inventory of lead safe housing units, and
- Expanding housing and services offered to homeless families and individuals
